IT IS on this 8th day of January, 2025;


ORDERED that the Complaint filed by plaintiff, Wells Fargo Bank, N.A., seeking to foreclose and recover possession of property known as Block 8001, Lot 6.05 on the municipal tax map of the Township of Hanover, New Jersey, also known as 9 Schindler Court, Hanover Township, New Jersey 07881, shall be, and hereby is, dismissed in its entirety and with prejudice; and it is further

ORDERED that the mortgage issued by Salvatore D'Uva and Maria D'Uva to First Union National Bank dated September 21, 1999, recorded in the Morris County Clerk's Office on October 21, 1999, in Book MB8772, Page 16, et seq., regarding the property known as Block 8001, Lot 6.05 on the municipal tax map of the Township of Hanover, New Jersey, also known as 9 Schindler Court, Hanover Township, New Jersey 07881, shall be, and hereby is, discharged and is of no force and effect; and it is further

ORDERED that the Notice of Lis Pendens recorded by plaintiff, Wells Fargo Bank, N.A., in the Morris County Clerk's Office as File Number 2025022866 on June 11, 2025, in Book 24931, Page 479, et seq., regarding the property known as Block 8001, Lot 6.05 on the municipal tax map of the Township of Hanover, New Jersey, also known as 9 Schindler Court, Hanover Township, New Jersey 07881, shall be, and hereby is, discharged and is of no force and effect; and it is further

ORDERED that a certified copy of this Order may be recorded with the Morris County Clerk; and it is further

ORDERED that a copy of this Order be served on all parties-in-interest within 7 days of the date hereof. *But not take effect for 45 days of this Date*
